**Jim Anliot** has served as Director of Healthcare Compliance Services for Affiliated Monitors, Inc. (AMI) since the company was founded in 2004. He serves as AMI's primary project manager for the performance of Independent Review Organization (IRO) services in connection with program integrity agreements between the Federal government and a wide range of healthcare providers, including medical and dental practices, clinical laboratories and nursing homes. In these cases, he oversees audits of provider payment claims and evaluates client policies, procedures and controls regarding service documentation, coding and billing.

Mr. Anliot also plays a major role in the delivery of AMI's independent practice monitoring services which evaluate provider compliance with enforcement orders issued by state licensing boards, Medicaid fraud control units, or other regulatory agencies. Because he served as legal counsel to state healthcare professional licensing boards in Massachusetts for sixteen years prior to joining AMI, he is familiar with current regulatory requirements and prevailing standards of practice in a broad range of health care professions, from medicine and chiropractic to mental health.

Mr. Anliot also assists both individual and organizational healthcare clients in developing or improving internal compliance programs designed to reduce the risk of adverse action by government regulators and improve patient care quality. He currently holds a Certification in Healthcare Compliance (CHC) issued by the Compliance Certification Board of the Health Care Compliance Association. Recognizing the importance of being proactive in identifying and correcting potential problems before they draw the attention of regulators, he works closely with AMI's clients to promote proper documentation and billing of services, appropriate patient referral and marketing practices, careful employee screening, sufficient protection of information privacy, and effective reporting, investigation and resolution of potential compliance issues. He has trained both clinical and non-clinical personnel on the implementation of these compliance programs in various practice settings.

During his tenure at AMI, Mr. Anliot has made numerous presentations to state agencies and national organizations about AMI's monitoring and compliance planning services, including two national "umbrella" organizations which provide information and technical assistance to state regulatory agencies throughout the United States. His work has earned the respect of regulators, attorneys and practitioners across the country.

Prior to becoming Director of Healthcare Compliance Services for AMI, Mr. Anliot served for sixteen years as legal counsel to various licensing boards at the Massachusetts Division of Professional Licensure (DPL) which oversee more than a dozen different health care disciplines. Before that, he served as a compliance specialist at the Division of Health Care Quality in the Massachusetts Department of Public Health, where he designed and implemented a pre-licensure screening program for prospective health care facility operators and authored Department regulations on reporting and investigation of patient abuse and neglect in nursing homes.
